#### **Summary**

Dr Linn has been working in the field as a Clinical Psychologist since 2017 within forensic settings and the private sector. She has worked providing assessments and intervention with adults, adolescents and children who have experienced moderate to severe mental health difficulties for over 7 years in Primary and Secondary Care Mental Health services. Dr Linn holds training in a variety of assessment protocols including risk, forensic assessments of psychological functioning and capacity, general diagnostic assessments for mental disorders, cognitive assessment, personality assessment and assessments for neurodevelopmental disorders. Dr Linn has worked with the mental health courts in Los Angeles, CA providing assessment of risk and expert witness testimony.

## **Experienced in the assessment of:**

- Child mental health: such as developmental trauma and the impact of abuse, neglect, and high conflict parenting. Attention Deficit Hyperactivity Disorder, Autism Spectrum Disorder, mood disorders and behaviours that challenge adults.
- Adolescent mental health: as per child mental health, and self-harm, and offending / behaviours that present a risk to others e.g., aggression and sexually harmful behaviour
- Adult mental health: such as PTSD and Complex PTSD & mood disorders, Personality Disorders, Learning difficulties, ASD, ADHD, Perplexing Presentations / Fabricated or Induced Illness by carers, substance misuse, behaviours that present a risk to others, high conflict parental separation.
